A. Personal data we process on our

Predict Marine processes personal data about you because you use our website and/or because you provide it to us yourself. Below is an overview of the personal data we process on our website:

B. Special and/or sensitive personal data

Predict Marine does not process any special and/or sensitive personal data about you on its website.

C. Why we need data

Predict Marine processes your personal datafor the following purposes:

- To enable the proper use of the website for you;
- Predict Marine analyses your behaviour on the website in order to improve our website and tailor our range of products and services to your preferences;
- Predict Marine tracks your browsing behaviour across different websites so that we can tailor our products and services to your needs.

D. Automated decision-making

E. How long we keep data

Predict Marine will not retain your personal data for longer than strictly necessary to fulfil the purposes for which your data is collected. Under the laws and regulations applicable to Predict Marine, we reserve the right to apply a retention period of up to 7 years for all (categories of) personal data.

F. Sharing with others

Predict Marine shares your website personal data with third parties as . necessary for the proper use of the website, for marketing purposes and to comply with any legal obligation. We enter into a processor agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. Predict Marine remains responsible for this processing.

G. Cookies, or similar techniques, that

Predict Marine uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone the first time you visit this website.

Predict Marine, on the one hand, uses cookies with a purely technical functionality. These ensure that the website works properly, can remember your preferences, for example, and help us make the website work properly. They also allow us to optimise our website

We also place cookies that track your browsing behaviour so that we can offer tailored content and advertisements. H. Viewing, modifying or deleting data

You can send a request for inspection, correction, deletion, data transfer of your personal data or a request to withdraw your consent or object to the processing of your personal data to info@predictmarine.nl. To ensure that the request for inspection is made by you, we ask you to send a copy of your proof of identity with the request. In this copy, black out your passport photo, MRZ (machine readable zone, the strip of numbers at the bottom of the passport), passport number and Citizen Service . Number (BSN). This is to protect your privacy.
